Pursuant to Regulation 30 read with Schedule III of the SEBI Listing Regulations, we wish to inform that the Department of Industries, Government of Rajasthan, has issued an Eligibility Certificate dated May 27, 2024 to ASK Automobiles Private Limited, Wholly Owned Subsidiary of the Company ("WOS" or "the Subsidiary") for eligible fixed capital investment ("EFCI") of Rs. 273.10 Crores (approx.)

Investment Subsidy:

- Reimbursement of 100% SGST due and deposited for 10 years
- Employment Generation subsidy in the form of reimbursement of 50% of Employer's contribution • towards Employees' EPF and ESI, for 7 years

Interest Subsidy: 5% interest subsidy on term loan taken by the Subsidiary from Bank(s), for making investment in plant & machinery, for a period of 5 years subject to a maximum of Rs. 25 Lacs per year

The total subsidies (Investment + Interest Subsidy) are subject to an overall capping of 125% of EFCI being a Mega Project.

Exemption: 100% Exemption from payment of electricity duty for 10 years, in addition to above
